Competitions Report - NS

Since my last report there has been one further competition.

I was very grateful to David Hobson and David Ross for standing in as judges at very short notice. This proved a useful opportunity to test the scoring system devised by Errol Levings and myself. All 4 of us are pleased by the robustness and repeatability of the system and suggest that it be adopted for next year.

Uptake for the HWC Shield Competition has been disappointing. Members should be encouraged to enter and be secure in the knowledge that private critique will always be available. Public critique should only occur with the permission of the entrant.

I suggest that the Experienced Class for The HWC Shield and the Christmas competitions for 2024/5 be renamed Open Class. This change would more truly reflect the population of the top group which may include relatively inexperienced woodturners who are of a standard at least one increment higher than the bulk of those members in the Intermediate group. The prize shield will have to be altered accordingly.

HWC Shield 2024 - Additional recommendations for 2024/5

- 1. Entry: Open to all paid-up members of the HWC.
- 2. Classes:
 - a. 3 classes will be offered: Novice, Intermediate and **Open**.
 - b. Class entry will be determined through discussion with the members of the HWC teaching and training team and will always involve the member when a change of class is recommended. The overriding principle will be to offer a fair level of competition within a class.
- 3. Judging:
 - a. Judging will be carried out to adopted criteria by a minimum of 2 judges. One of whom should have previous HWC judging experience.
 - b. Any HWC member may be a judge but those not experienced in judging to the agreed criteria should be accompanied by an experienced judge.
 - c. If one or more judge(s) has entered the competition, a replacement judge(s) will be recruited if required for that class.
- 4. Points:
 - a. Points will accumulate throughout the year.
 - b. 1st: 10points. 2nd: 9 points. 3rd: 8 points. 4th: 7 points. 5th: 6 points. 6th and all other entries 4 points.
